Limited Warranty: Builder's Best, Inc. ("Builder's Best") warrants that products manufactured by Builder's Best ("Products") will be free from defects in material and workmanship for a period of thirty (30) days from the date of installation (the "Warranty Period"). This Limited Warranty is not transferrable; it extends only to the original purchaser of Products ("Purchaser") who purchased Products either directly from us or through one of our authorized distributors ("Authorized Distributors").

If a Product fails to meet the warranty set forth above during the Warranty Period due to Builder's Best's fault, Builder's Best will repair or replace the Product (with new or rebuilt Product) or provide you with a refund of the original purchase price of the Product, at Builder's Best's discretion. This Limited Warranty sets forth your sole and exclusive remedy for any defect in the Products. The foregoing remedies may only be available subject Builder's Best's technical inspection of the Product.

Exclusions from Coverage: This Limited Warranty does not apply to (i) Products that were not purchased directly from Builder's Best or an Authorized Distributor; (ii) Products purchased through unauthorized channels; (iii) materials that were not manufactured or developed by Builder's Best; or (iv) damage due to (a) improper use, (b) failure to follow Builder's Best's installation instructions or failure to maintain the Products under conditions specified in Builder's Best's performance data, (c) alterations or modifications, (d) unauthorized repair, or (e) external causes such as accidents, abuse, or other actions or events beyond Builder's Best's reasonable control.

 received without an RGA will not be accepted and will be returned to you at
