## NEW BV AND BVO TYPE B GAS VENT MODELS

In April of this year, Duravent Group began the process of phasing out models GV and GW type B gas vent. This decision corresponded with the launch of the new BV and BVO type B gas vent models, a direct replacement for GV and GW products.

This transition is nearly complete! In the coming weeks the GV & GW product lines will start to ramp down production. All GV & GW production will end on October 31, 2022. However, while inventory remains available, Duravent will continue to accept orders for in-stock GV and GW finished goods until 3/31/2023.

Duravent will continue to honor product warranties for the duration of the warranty period. If the terms of the warranty call for product replacement and the GV/GW product is unavailable, the product will be replaced with the equivalent BV/BVO product.

We sincerely appreciate our customers' support through this transitional period. The Duravent team is focused on and committed to providing customers with exceptional products at a superior value, and this phaseout is an important step towards achieving that objective.
